1. DISCLOSURE OF INTERESTS & DISPENSATIONS

County Councillor Davies as Carmarthenshire Planning Committee Vice Chairman, Llansteffan and Llangain School's Governor & Llanybri Hall Committee Chairman; Councillor Howells as Llansteffan Church Warden, Parochial Church Council Member & Llansteffan School Governor Chairman and Council Rep; and Cllr Dr Hunter as Llansteffan Memorial Hall Chairman.

2. MINUTES OF MEETING HELD ON 22nd JUNE 2015

3. MATTERS ARISING FOR INFORMATION

Pet memorial

The pet memorial adjacent to the Croft footpath in Llansteffan had been removed.

Morfa maintenance contract

No tax-related problems identified at this stage and hence no need for a meeting to-date. 129

Llanybri Ward vacancy

County Council Electoral Services had advised that local electors had not requested a bye- 130 election and therefore the Council should publicise its intention to co-opt a councillor.

DMMO/Footpath Creation Agreement Wharley Point The Pheasantry

The Countryside Access Manager had stated that Mrs Rhys wished to resolve the footpath issue amicably via the Creation Agreement process and had asked him to draft an Agreement on the basis of the National Trust boundary currently registered. Mrs Rhys appeared to accept that the path could be recorded as 2 metres in width up to the gable end of The Pheasantry and then 1.2 metres as it ran past the building to the road to the north-east. The National Trust had already indicated that a footpath of 2 metres width on their land was acceptable.

Llanybri village roads

Cllr DB Davies had had discussions with the Assistant Area Manager who had confirmed there were a few roads which were in a very poor condition. Two roads had been 'surface dressed' within the current surface dressing programme. However, the U2127 Llanybri Village and C2081 Lanmartin to Coombs Cross needed to be fully resurfaced using tarmacadam and had been included in the programme of future resurfacing schemes. It was hoped there might be some surplus funds available at the end of the financial year, which could be released to carry out several resurfacing schemes across the county on a needs assessment basis.

PSOW Report

Cllr Cooper raised a point of order regarding the inclusion of the item: 'PSOW Report and 133 Lessons of Good Practice' on the July agenda without prior discussion within the June meeting. He concluded with a request to delete the item from the agenda. The Clerk reminded members

that prior consent had been given for annual leave to be taken from 12-22nd June due to participation in a Help for Heroes cycle challenge. June agendas had therefore been printed and distributed prior to the receipt of the Report, and hence any reference could only be made under Matters Arising for Information. For clarification, the Chair drew attention to the fact that as the September 2014 Council minutes had recorded that a Code of Conduct complaint had been submitted to the PSOW, it was right and proper that Council minutes should record that the Report had been received. In sum, the item would be retained on the agenda.

4. COUNTY COUNCILLOR REPORT

Members were informed that the wind turbine planning application at Mwche Farm would not 134 be pursued by the applicant for the reason that the feed-in tariff paid for electricity generated had significantly dropped and the turbine no longer represented a cost-effective investment.

5. HEALTH & SAFETY REPORTS

Morfa Playground

It was reported that new springs had been fitted to secure the two access gates and a key had been obtained to enable the square litter bin to be emptied. Carnival weekend on the Morfa would attract more usage and more discarded rubbish. Painting of equipment where required would be undertaken before the autumn/winter.

Carrier's Lane

Cllr Howells had met with a service supervisor who organised the annual cut of Carrier's Field 136 and had given assurances that the Safe Route to School behind Glan y Mor would be regularly trashed. Overgrowing private hedges towards the bottom of the lane had been cut back.

<u>Morfa</u>

The folly bridges had been trashed and cleared by Sports Club volunteers in response to the Council's written request. The annual letter plus public liability schedule (£5 million cover) had been received from the Sports Club requesting permission to use the Morfa for carnival weekend 31st July to 2nd August. Cllr El Davies, Council Rep at Sports Club meetings, raised concerns about potential use of barbed wire and herbicides on the Morfa.

Resolved

- i) That permission be given to Llansteffan Sports Club to use the Morfa for carnival 138 weekend 31st July to 2nd August:
- ii) That the County Council as landowner be requested once again to carry out a 139 public health and safety risk assessment on the Morfa pond:
- iii) That a letter be written to Llansteffan Sports Club stating that neither barbed wire 140 nor herbicides should be used on the Morfa for public health and safety reasons.

<u>Croft</u>

The verges had been trashed which controlled all types of weeds and grasses, unlike in recent years resulting from the ineffective application of herbicide. Both the public seats and flower pots looked attractive despite days of inclement weather.

Headland Path

It was reported yet again that clearance was still required of the encroaching bramble and overgrowth at both First and Second Steps and on the downhill section to Scotts Bay. The clerk had been informed that contractors were now responsible for maintaining the Wales Coast Path and works should be done in the near future. On a positive note, the accesses to footpath 23/21 from Old Road to Llanybri Road, and the kissing gates had been cleared.

Hen Gapel

Cllr El Davies had taken over the monthly inspections from ex-Cllr Perrett. The missing slate to 143

the front of the chapel tower, and the loose slate to the rear remained an issue. Cadw's Field Inspector had visited on 7th July and noted the need for roof repairs and routine maintenance. The Council had been informed that (i) removal of the encroaching vegetation would release the final Maintenance Agreement payment; (ii) an Ancient Monument Grant could potentially cover 50% of the costs of roof repairs, but the next round did not open until November; (iii) horizontal slates needed to be re-fixed to cap the low stone wall opposite The Farmer's and local stone mortared in at intervals to deter the problem of slates being stripped which allowed water penetration to the structure.

Resolved

- i) That a public notice be displayed inviting quotations in accordance with a 144 Schedule of Repairs required at Hen Gapel Llanybri;
- ii) That delegated authority be given to the Chair, Vice Chair, Cllr Charles and the 145 Clerk to appoint a suitably qualified contractor to repair the chapel tower roof and undertake routine maintenance in accordance with the Schedule of Repairs, subject to a maximum outlay of £1500.

Citizens Advice - Defined Contribution Pension Scheme

A letter was received advising that new pension freedoms came into force on 6th April 2015 for 157 accessing Defined Contribution schemes more flexibly. The Pension Wise Guidance Service provided free, impartial and confidential guidance to help understand the new options.

Welsh Government - "Protecting Community Assets" consultation

An email was received seeking views on how assets were run and services were delivered. 158

Resolved

That the Chair, Clirs Howells and Cooper and the Clerk be given delegated responsibility 159 to make an informed written response to the Welsh Government "Protecting Community

Assets" consultation by the 11th September deadline.

Carms County Council - Safe Routes in Communities Grant

An application form was received inviting projects that reduced congestion, improved road 160 safety, reduced reliance on the car and improved the health and well-being of children and adults. This was an annual grant which required a long lead up period of partnership-working.

One Voice Wales - Annual Conference "Local Government Reform."

8. PLANNING MATTERS

To note that an objection be raised to the following application on these grounds: (a) 163 Loss of three residential units from the original application (W/18740), namely from a block of six apartments to a terrace of three executive-style houses; and (b) The current application bore no resemblance to the original approved application (W/18740), the latter having resulted from a lengthy 2-3 year negotiation process and the loss of an historic building. Post-planning consent negotiations which secured one amendment after another to change an original approved scheme were not favoured by the Council. W/32215 Construction of three houses in replacement to the planning permission for a block of six apartments under planning consent W/18740 at Llys Steffan Llansteffan

9. LLANYBRI PLAYGROUND GRANT SOURCES

The Community Bureau had informed the Council that registered charities were eligible to 164 apply for funding from the Garfield Weston, Bernard Sunley and Morrisons Foundations. In consequence it would be advantageous if Llanybri Community Association, Reg. Charity No. 1090695 could apply for the balance of £26,530 required to develop the playground at Heol Fain, Cllr DB Davies, an Association trustee, confirmed his support for this plan of action.

Resolved

- That the Clerk be authorised to explain the Llanybri playground grant funding 165 situation to Llanybri Community Association trustees and treasurer and seek their approval to submit grant applications to private charitable foundations;
- ii) That, subject to securing the consent of all parties, the Clerk be authorised to 166 submit Llanybri Playground grant applications to private charitable foundations on behalf of Llanybri Community Association.

10. PSOW REPORT AND LESSONS OF GOOD PRACTICE

The Chair asked members whether they wished to consider this item. 167

Resolved

That Council should consider the item on PSOW Report and Lessons of Good Practice 168 at the July meeting.

The Chair explained the two reasons for including the item on the agenda as follows:-

- (a) A Council minute needed to be recorded that the PSOW investigation had been completed and the Report had been received by the Council;
- (b) Council needed to determine whether Standing Orders had to be re-visited and possibly added to in the interests of effective governance.

Cllr Howells moved that the Council received and accepted the Report and took no further 170 action. Cllr Cooper proposed that Cllr DB Davies deserved a public apology in the press; this proposal was seconded by Cllr DB Davies.

Resolved

That the Council did not support the proposal for a public apology to CIIr DB Davies to 171 appear in the press on the basis that negative personal and community feelings would be inflamed once again (6 votes = not in support of the proposal; 2 votes = in support).

Cllr Cooper stated that he reserved the right to publish the matter in the press at the earliest 172 opportunity. On the grounds that the PSOW had decided to take no action with regard to the Code of Conduct complaint, Cllr DB Davies asked Cllr Cooper to withdraw his proposal.

Resolved

That neither a public apology to Cllr DB Davies nor the PSOW Report would be 173 publicised in the press in accordance with Cllr DB Davies' wishes (8 votes = in support).

In conclusion, the Chair stated that the Council had acted in a professional and ethical manner throughout what had proven to be a difficult year for all members and the local community. All agreed that the issues surrounding 'twin-hatted' councillors and their involvement in county and local council sectors were problematic. The clerk would produce a summary of lessons of good practice for the benefit of both present and future clerks and councillors.

11. DRAFT FINANCIAL REGULATIONS

The Clerk informed members that a first draft had been produced based on the Model Financial 175 Regulations advocated by the National Association of Local Councils and One Voice Wales.

Resolved

- i) That a sub-group comprising of the Chairman, Cllr Cooper and the Clerk be 176 authorised to prepare a final draft of the Council's Financial Regulations for consideration by full Council;
- ii) That Council's Financial Regulations be itemised on the October agenda.

12. ANNUAL RETURN 2014/15

Resolved

That the Annual Return 2014-15 be accepted and approved by the Council on the basis 178 that no issues had been raised by the external auditor, BDO LLP.

13. PUBLIC HEALTH (WALES) BILL - PART 6 TOILET STRATEGY - DRAFT RESPONSE

Members considered the draft representation prepared by the Clerk for submission to the 179 National Assembly's Health and Social Care Committee. A proactive stance was advocated to build upon the success of West Carmarthenshire and South Pembrokeshire cross-party action in ensuring that public conveniences in five tourist villages in Carmarthenshire remained in the ownership and management of the County Council. The Clerk was thanked for producing a comprehensive document. The Chairman requested the addition that the toilets on The Green Llansteffan had been closed several years ago - an action which had resulted in on-going complaints and environmental health issues.

Resolved

That the Council's draft response to the Public Health (Wales) Bill Part 6 Toilet Strategy 180 be accepted and submitted to Welsh Government for the attention of the National Assembly's Health and Social Care Committee.

14. MATTERS FOR INFORMATION ONLY

- The Head of the National Botanic Garden had given a presentation to the County 181 Council and the latter was undecided about supporting the Garden to the tune of £75k.
- Cllr Dr D Hunter declared an interest in the National Botanic Garden as regular volunteer 182 and supporter and reminded members that the Garden had to source 70% of its annual funding, whilst Edinburgh National Garden was fully funded and Kew National Garden

	only had to source 30% funding.
