Ar ôl derbyn cyngor y bargyfreithiwr ynglyn â gwrthdaro posib yn nefnydd tir sydd wedi'i gofrestru'n Village Green, mae'r cyngor sir yn ystyried strategaethau i ymateb i sawl problem ar y Green, Llansteffan. Mae elfennau o fewn y strategaethau hyn angen cyngor pellach gan fargyfreithiwr er mwyn sicrhau eu bod yn gyfreithlon ac y gallir eu hamddiffyn rhag unrhyw her cyfreithiol yn y dyfodol, petai'r sefyllfa'n codi. Ar ôl derbyn y cyngor cyfreithiol hwn bydd y Sir mewn sefyllfa i ddatblygu cynigion i'w trafod gyda'r Cyngor Cymuned ac, mewn partneriaeth gyda'r Cyngor Sir, i ystyried cynllunio ymgynghoriad ehangach yn y gymuned i sicrhau bod cefnogaeth i unrhyw gynigion gan gymuned Llansteffan drwyddi draw.

THE GREEN, LLANSTEFFAN:

I have received an update regarding progress on matters of The Green, Llansteffan. Following receipt of the barrister's advice regarding potential conflicts of uses of land registered with Village Green status, the County Council is considering strategies to address various issues on Llansteffan Green. Elements within these strategies require further legal advice from the barrister to ensure that they are legally sound and can be defended from any possible future legal challenge, should the need arise. On receipt of this advice the County will be in a position to develop proposals for discussion with the Community Council and, in partnership with the Community Council, consider a wider community consultation exercise to ensure that any proposals are supported by the wider Llansteffan community.
