## Item 5 – Materion yn Codi: Hydref 17<sup>eg</sup> 2022 / Matters Arising: 17<sup>th</sup> October 2022

- Some damage had been done to the grass area when the new play equipment was installed in Parc Adrian but as the grass has now been moved and it is looking better. The equipment that was damaged has been looked at with a view to repairing as soon as possible.
- It was agreed to send a letter of thanks to the Llanybri Rangers for their donation.
- Llanybri Councillors to agree where the donated tree will go in the play area.
- The roots have been removed from under the climbing frame on the Morfa play area. E Evans to be asked to complete work to spread bark. Bark to be ordered by Clerk.
- Recognised that a bigger bin or two bins would help with the added refuse at the bottom of Ferry Lane. The Scott's Bay bin also often overflowing.

- Bell House panel to be moved due to encroaching undergrowth
- Yr Hen Gapel: Conditions set by CADW have been accepted by contractor. Contractor to advise date/s
  to LLCC & CADW prior to work starting and upon completion
- Llansteffan noticeboard no tenders were received. LLCC resolved to accept the kind offer of completion of a noticeboard by John Evans (free of charge) but with cost of materials covered at £113 Proposed Cllr James Seconded Cllr Thomas
- Second trashing from top of Plas Hill to Llanybri has been placed onto cyclic team schedule by I Thomas from CCC Highways
- Overflowing glass recycling at Capel Newydd, Llanybri, to be reported
- Cllr James to liaise with E. Davies regarding Nant Jac path. It was resolved to request work from R
  Davies if E Davies is unavailable to complete within two weeks

- Cllr Jones thanked the County Council for the work done on providing an extended handrail at first steps.
- Councillors highlighted that there are emerging parking issues on Clarence Hill making it difficult for drivers to have line of sight around a bend.

- A member of the public spoke about the need to continue to pursue the DMMO claim on the Pheasantry footpath. This was supported by four other members of the public.
- Cty Cllr Hughes spoke about the requirement to provide toilet facilities within Llansteffan North Car Park.
