Mae'r Agenda hon wedi'i llunio o dan adain Deddf Llywodraeth Leol ac Etholiadau (Cymru) 2021 sy'n nodi:

6.4. Mae paragraff 21 o Atodlen 4 i Ddeddf 2021 yn nodi, o dan amgylchiadau eithriadol, y gellir galw cyfarfod pwyllgor neu is-bwyllgor y cyngor ar fyr rybudd. Os felly, dylid cyhoeddi hysbysiadau gydag o leiaf 24 awr o rybudd. 6.5. Dylid defnyddio'r ddarpariaeth i alluogi cyfarfodydd brys mewn modd priodol yn unig ar gyfer materion y mae angen ymateb ar frys. Mae hyn yn adlewyrchu'r ddarpariaeth debyg sydd ar waith ar gyfer prif gynghorau, e.e. i ffurfio ymateb brys i lifogydd lleol neu argyfwng iechyd cyhoeddus. Cynghorir cynghorau cymuned i baratoi rheolau sefydlog ar gyfer y broses a'r rhesymau dros alw cyfarfodydd brys o'r fath, gan gynnwys sicrhau cefnogaeth gan bob aelod o'r cyngor.

This Agenda is constructed under the auspices of The Local Government and Elections (Wales) Act 2021 which states:

6.4. Paragraph 21 of Schedule 4 to the 2021 act notes that in exceptional circumstances, a meeting of a committee or sub-committee of the council may be called at shorter notice. In which case, notices should be published with at least 24 hours' notice. 6.5. The provision to enable urgent meetings should be used only in an appropriate manner for matters which require urgent response. This mirrors similar provision in place for principal councils, e.g. to form an emergency response to local flooding or a public health crisis. Community councils are advised to prepare standing orders for the process and reasons for calling such urgent meetings, including the securing of support from across council members.
