This discussion will include accessibility requirements, security notices and the cost of maintenance provision.

Mae'n bosib bydd angen cyllido ar gyfer taliadau i Llanybri a Llansteffan. Y swm yn y gyllideb ar hyn o bryd yw £300 / To discuss the payment of power for Christmas lights in Llanybri. Historically LLCC have paid for the unmetered supply until 2017 but have not paid since. This may require budgeting to pay both Llansteffan and Llanybri. Current budget figure £300.

This may require budgeting.
